Parents should be aware that the statutory guidance states that 'issues of a personal or individual nature relating to a specific child or member of staff must neither be the subject of, nor discussed in detail at, a meeting.'

The Governing Body has added the following matters, which relate directly to the matters on which the petition is based:

The required quorum of governors will be 50% rounded up to the nearest whole number. The required quorum of parents shall be 50% of the number of parents that signed the petition. Should insufficient governors or parents attend the meeting to meet the required quorum, it will not be possible to proceed with a formal meeting.
